The last decades have undergone extraordinary changes within the food safety field, and although the regulation framework on food contaminants in the European Union was established in 1993, it was not until the publication of Regulation 178/2002 when the issue was globally approached in accordance with the principle of risk analysis.

The objectives sought with this event are:

- ➔ To help improve the knowledge on contaminants in food in the framework of risk analysis.
- → To provide a better understanding of the risk management of pollutants both in the field of food safety and related fields.
- ➔ To set a discussion among all the stakeholders involved in risk communication on food contaminants.

The workshop was divided into three thematic sections that correspond to the three elements of risk analysis (assessment, management and communication), taking into account that the AESAN is responsible for three areas nationwide.

This workshop is intended for the competent authorities responsible for the control and management of food safety, FBOs and consumers.
